

#### Dementia awareness month

What are the characteristics and outcomes of patients with dementia admitted to NHS hospitals in England?



#### Methodology

- Data was extracted from Hospital Episode Statistics for the financial years 2019-2024.
- People with a diagnosis of dementia were included.
- Patients were described by age group and biological sex.
- The diagnosis on admission were recorded.
- The number of deaths were recorded.
- The number of days from first hospital admission with a diagnosis of dementia recorded to death were recorded for patients who died in hospital.


# Annual admissions to hospitals in England for people with dementia

## Age on admission




Admission to hospital with admission largely affects the older population older than 70.

## Overall mortality and time to mortality

- There were 602,650 persons admitted with a diagnosis of dementia over the 5 years of data.
- 139,562 persons had a death recorded in hospital.
- The median time (midpoint number of days) from the first admission with a diagnosis of dementia to death, in those people who died was 35 days.
- The mean time (all days divided by number of deaths) was 219 days.
